- (1) The discharge of untreated sewage is from L & L Oddysey Complex, Margao. Also the Nullah flowing from Margao into Salphem lake, Nvelim; carries sewage from Margao as many/all domestic exit pipes of untreated sewage is left into the Nullah which has made way to the Salpem Lake Which is polluted and hence uncultivable.
- (2) The residential houses and complexes in Navelim Village; have made adequate arrangements for treatment of sewage with necessary septic tanks and soakpits. The same is ensured / confirmed by the Health Authority and the Panchayat, before issue of Occupancy Certificate
- (3) The Panchayat has acted consequent upon complaint of overflowing of septic tanks and enough measures are being taken to rectify the irregularity by utilizing services of night soil tankers and repairs of septic tanks and soak pits.
- (4) The Panchayat has acted swiftly and issued instructions to clear such residue affecting nullahs and streams.
- (5) The Panchayat undertakes plastic waste collection from Door to Door, segregates and disposes the same in a safe manner. However the Panchayat maintained that collection of solid waste is not being done since it does not having a suitable site for disposal.
- (6) The Panchayat resolved to take up awareness among public and student community for a need to treat and dispose sewage and solid waste thereby prevent pollution in river and water bodies.
- It is further resolved to submit a report accordingly to the Goa State Pollution Control Board in this respect.
