The Chair informed the members that this Panchayat has issued work order to Solutions, Comba Margao, Salcete Goa being the lowest amount quoted in respect to quotation notice No. VP/N/427/2020-21 dated 04/08/2020 of this Panchayat in respect to the subject cited above. The same is followed by this Panchayat in compliance to circular No. 26/DP/SBM(Gramin)19/2020/5178 dated 25/07/2020 regarding the steps to be taken by the village Panchayats in the jurisdiction of V.P. Navelim, Salcete for collection and disposal of Bio-medical waste generated of Home care for Covid-19 asymptomatic positive patient. the contents Secretary The explained of the circular No. 26/DP/SBM(Gramin)19/2020/5178 dated 25/07/2020 to the members in detail. Upon perusal, the members opined that the same is in the purview of the Health Center and involving the Panchayat in pasting home isolation stickers on the door of the house of Covid-19 asymptomatic positive patient and handing over the yellow and red bags to their home for collection of Bio-Medical waste is morally deplorable. It is further discussed that Health Department is equipped with all the precautionary requirements such as PPE kits etc. for safety and also with required funds where as the Panchayat isn't trained nor provided with any safety kits to avoid acquiring the COVID-19 virus by visiting the sites from the ones who are affected. It is also discussed that the Primary Health Center of Navelim is not providing any Co-Operation to Village Panchayat Navelim, Salcete in any matters related to the Pandemic. Further, the members opined that the responsibility of pasting home isolation stickers on the door of the house of Covid-19 asymptomatic positive patient and handing over the yellow and red bags to their home for collection of Bio-Medical waste should be assigned to the contractor to whom work order has been issued as this Panchayat has to utilize Panchayat funds for the purpose. Also, there is no certainty as to till when the said work order shall remain active as the Panchayat is made bound to incur the expenditure in respect to collection and transportation of COVID-19 Bio-Medical waste of the Covid-19 asymptomatic positive patients in the jurisdiction of Village Panchayat Navelim. The body unanimously resolved to request the Block Development Officer to surge the matter with the Concerned Authorities for efficient planning in respect to the subject matter.
