Adelina Fernandes informed that the height of the over bridge for western bypass which is in the process of Construction at Nagmodem, Navelim seems to be less i.e 3.5 mtrs. which is inappropriate for vehicles like buses, trucks to pass through; this shall put the public using the service of the said vehicles for their purpose into inconveneince. Also in times of emergency for a Fire Brigade, leading to and fro to Nagmodem and Sinquetim will have to follow a lengthy route / diversion due to the less height of the Bridge which shall put life and property at risk in the times of need for fire brigade. She re-iterated the said bridge is supposedly to be of 5 mtrs height as committed, and that the height given to the said bridge is of 3.5 mtrs is unjust for the public which shall restrict free flow of vehicles like buses, trucks and fire brigade to whom service road becomes mandatory for use having no alternative. After lengthy discussion it is unanimously resolved to request the Executive Engineer (PWD), Works Div. XIV(NH), Sub Div III, Margao to raise the height of the over bridge for western bypass which is in the process of Construction at Nagmodem, Navelim so as to avoid the inconvenience as discussed in this resolution.
