- 3 (25) W.r.t Letter dated 18/12/2020 From the office of Goa State Pollution Control Board, Saligao regarding Directions under Section 5 of the Environment (protection) Act 1986 Read with the Solid waste Management Rules 2016, it is unanimously resolved to submit pointwise reply in the matter as under:-
- 1) In respect to Sr. No. 1, in regards to composting facility for treatment of wet waste, this Panchayat has installed a Wet Garbage composting machine of 75kg capacity per day in the premises of this Panchayat to handle wet garbage and also 1000 lts capacity Black Soldier Fly Larvae Composting units (4 Nos) & 300 Lts Capacity (4 Nos) has been installed and are operational. As per Solid Waste Management Rules 2016 each house hold treat their wet waste as source by way of various methods for which Panchayat assist them. Some households have installed Black Soldier Fly larvae wet waste composting units in which wet waste is fed to the BSF larvae, in turn grown up larvaes are fed to the back yard poultry birds, leachet is used as organic liquid manure and solid compost for the plants. Bio Digesters are also installed by some of the individual households, where wet waste is converted to bio gas for cooking. Some households use Khamba Composters as well as Traditional Composting Pits. Further, Compliance of waste composting is sought by the Panchayat before issuance of Occupancy Certificate along with Affidavit which is applicable for single dwelling units and so on. Further, you may please guide this Panchayat in respect to increasing the capacity of composting facility to 3.5 tons / day.
 - 2) In respect to Sr. No. 2, this Panchayat is collecting dry garbage from the households in its jurisdiction fortnightly and the same is done on a regular basis. You can assess the same on the amount of garbage handed over to the Goa Waste Management of which timely reports are been submitted annually. Village Panchayat requires to improve and enhance the collection mechanism of non-biodegradable waste.
 - 3) In respect to Sr. No 3, this Panchayat shall hence forth direct the Local pharmacy and shops to provide a box for collection of domestic hazardous waste. Also this Panchayat make efforts to provide box for domestic hazardous waste and shall also make efforts to create awareness in respect to the same.
 - 4) In respect to Sr. No. 4, this is to inform you that this Panchayat is in the process of setting up Material Recovery Facility Centre for waste Management in the open space (Gift Deed) of Land bearing SY. No. 175/1-G, Moddi, Navelim Salcete Goa. Necessary approvals have been granted and further process of tendering the said work shall be done accordingly.
 - 5) In respect to Sr. No. 5, this is to inform you that Authorization from your Office for treating the wet waste shall be duly complied as per your guidance. You are therefore requested to.
 - 6) In respect to Sr. No. 6, kindly inform whether the Rule 4 & 15 is of the Environment (Protection) Act, 1986 or of the Solid Waste (Management) Rules, 2016.

7) In respect to Sr. No. 7, this Panchayat has empaneled 3 Waste Management agencies ie. V-Recycle, Alterenergyz & Bhavish Goa. This panchayat has confirmed with the said agencies where-in it is informed by them that they are handing over the segregated dry waste to GWMC site at Verna.

Further, it is apprehended that Rs. 5,000/- as penalty towards compensation for damage to the environment is contradictory as this Panchayat can get away with all of the directions under section 5 of the Environment (Protection) Act 1986 very conveniently only by making a payment of Rs. 5000/- to your office which may be a yearly process followed by GSPCB. Therefore, this Panchayat could not ascertain GSPCB's role in the matter as to whether its office would guide this Panchayat in implementing directions under section 5 of the Environment (Protection) Act 1986 into practice or whether they would only send notices for payment of fines and would collect Rs. 5000/- and do away with it. If so than to reply that this Panchayat is of an opinion that making all the efforts in curbing the garbage menace in its jurisdiction is only a waste of time and public fund where-in we can easily save our time by making a payment of Rs. 5000/-.

Further, this Panchayat has reported that expenditure is a big concern towards handling of garbage, inspite of which this Panchayat is incurring a huge expenditure from its own fund towards handling of garbage as there is no Aid received whatsoever from the Government.

That being said, you may also note that this Panchayat has never received any assistance from GSPCB office whatsoever in tackling the garbage problem in its jurisdiction neither any meetings are been held to work out on the problems faced by the Panchayat as is quite apparent that Goa State Pollution Control Board is not only to collect fines / penalties but through its resources should also provide every assistance in implementing directions under section 5 of the Environment (Protection) Act 1986. Only than the Panchayat could achieve the desired success in handling the garbage as defined in the said Act. After lengthy discussion it is unanimously resolved to forward this resolution and seek advice in the matter after which this Panchayat shall make payment of Rs. 5000/- as penalty.

3 (26) W.r.t Order Ref. No. 19/DP/Order/V.P. Staff/2020-21/7752 dated 08/12/2020 from Directorate of Panchayats, Govt. of Goa, 3rd Lift 3rd Floor, Panaji Goa in respect to mode of Recruitment of Panahcyat Employees and Staffing Pattern, the members unanimously noted the contents of the same. Further it is unanimously confirmed that this Panchayat has obtained approval from the BDO vide no. 3/Approval/Navelim/BDOS/2019-20/1451 dated 04/06/2019 for filling up the vacancy of V.P. Clerk. After going through it is unanimously resolved to initiate receuitment process as per the Goa Panchayats (Staffing Pattern, scales of Pay and mode of recruitment of staff of Panchayats) order 2003 as specified in the Order dated 08/12/2020 referred here-in above.

- 3 (27) W.r.t Letter dated 28/12/2020 of Rolt C. H. Coutinho, regarding Change of name of firm, it is unanimously noted that the validity of the conditional NOC granted to you for business of Commercial activity (Office for Courier Service) under name and style "Time Saving Couriers." in premises bearing H. No. 499/8/1(i), Dongorim, Navelim ends on 22/02/2021. Since the same is almost near to ending its validity; it is unanimously resolved to request the applicant to produce the O/C copies (Acknowledgement) of the requests made by him to the concerned NOC's for their consent in the name of "Time Saving Couriers". It is also resolved to request the applicant to seek status report with the concerned dept. in the matter on the basis of his request so as to produce the same in the office of V.P. Navelim after which the matter may be accordingly decided for grant of time and change of name from "Time Saving Couriers" to "R.C. Group". It is further resolved to request the applicant to surrender the NOC's issued to him in original (Final NOC with the Last Renewal NOC) to this office for the purpose.
