It is further confirmed that Ganpat Xiru Lorlikar has already submitted his say in the matter to the Panchayat where-in he has stated that he has kept in access located to the northern side of his property. It is concluded that the access mentioned by the complainant is passing through the property of Ganpat Xiru Lorlikar to others property to connect to the main road and therefore without the NOC's from all such soncerned landlords the matter connot be perused further. It is also resolved to refer the matter to Police to explore if there is any possibility of amicable settlement between the applicant and respondent.
- 3 (10) Order dated 02/12/2020 From the Office of Directorate of Fisheries, Panaji Regarding appointment of officers for Swayampurna Goa and Atmanirbhar Bharat programme for creating awareness, sensitization, popularization, monitoring and successful implementation of Government schemes for the state, is unanimously noted.

- 3 (14) W.r.t this Panchayat Resolution No. 5(29) of the Meeting held on 18/05/2020; the Sarpanch informed the members that in the said resolution it is decided to take stringent action against the Concerned Staff if found under the influence of alcohol during office hours. In connection to the same she informed that inspite of this Panchayat explaining the Consequences of the said resolution to Mr. Agnel Pereira V.P. Peon; he used to often report to the office in drunken state. However, the undersigned had only given him verbal warnings and never initiated harsh action against him with a hope of seeing some improvement but the same went in vain only to realize that this Panchayat is at fault of not doing so in time. She further informed that it is high time as Mr. Agnel Pereira has gotten to the nerves of this Panchayat as he has exhibited negligence towards his duties as V.P. Peon of this Panchayat by not performing his duties to the satisfaction of the Panchayat being in drunken state. She further informed that on 10th Dec 2020 he was found in drunken state and was not at all in the position to work and was not even able to walk firmly which is also witnessed by the other staff present on duty, hence he was asked to leave the office for the day and that the next day he repeated the act and reported to the office in the morning in drunken state hence once again he was asked to leave the office for the day. She further informed that it was anticipated that he shall report to the Panchayat as a gesture of repent and obligation towards his employment with the Panchayat and shall promise that he will not repeat the said act, however he has failed to show any repentance for his act and continued to remain absent till date which is un-authorized. This has gravely tarnished the image of V.P. Peon of V.P. Navelim and have adversely affected the repute of this Office. This irked the members present as the concerned staff is exhibiting a negligent behavior towards the office time and again. They presumed that Mr. Agnel Pereira is in no mood to show any improvement in himself rather he is fine remaining absent from attending his duties as V.P. Peon and that he is not ready to give up on his habit of consumption of alcohol and reporting to duties in drunken state. They reiterated that this is not at all acceptable as he has crossed the limits of chances given and that he is not worthy of more since he is becoming more and more worse rather than showing sort of improvement in himself, also it is setting up a wrong any

example among the other staff. They expressed their grief due to the inconvenience caused to the office in the absence of V.P. Peon especially during this Pandemic situation. It is asserted that Mr. Agnel Pereira has been served Memorandums in respect to his Negligence towards duties a several times which did not serve any purpose as it has not brought the concerned staff into control as if he has pre-determined his mind with an assumption that he will escape everything with ease being on a permanent position of employment as V.P. Peon. After lengthy discussion the members unanimously resolved to initiate stringent action against Mr. Agnel Pereira as mentioned in this Panchayat Resolution No. 5(29) of the Meeting held on 18/05/2020. It is further resolved to include termination of his service permanently as part of stern action and issue Memorandum/Show Cause Notice to the concerned and further report the matter to Higher Authorities.
