Proceedings of the extraordinary Gram-sabha meeting held on 26/06/2022 at 10 AM in the Panchayat hall. The meeting is to declare Navelim Village under ODF plus Aspiriny Category.

The Administrator Ms Atchaya Thal Desai presided over the meeting.

The members Panchayat members including Panchayat Gram-sabha members who have signed on the register have been maintained separately by this Panchayat.

At the outset after fifteen minutes from the appointed time there was no required quorum, hence Administrator adjourned the meeting for half an hour and then informed the Gram-sabha members that the said meeting will start sharp at 10.45 AM irrespective of quorum present for the meeting.

At the outset Administrator welcomed the Gram-sabha members and introduced herself and further requested all the Gram-sabha members present to cooperate her to conduct the meeting in a peaceful manner.

Administrator Ms Atchaya Thal Desai informed the Gram-sabha members that this Panchayat received a memorandum NO 26/DP/SBM/G/2020-21/8122 dt 21/6/2022 from Directorate of Panchayat on 22 June 2022 and after going through the memorandum she immediately issued Gram-sabha meeting notice on 23/6/2022, hence sufficient time could not be given to publish the said notice.

Secretary read out the said memorandum to the members of Gram-sabha in detail for further.

Further Administrator explained the contents of the memorandum in detail to the Gram-sabha members and placed the proposal before the Gram-sabha for taking necessary decision to declare the Navelim Village under ODF plus Aspiriny Category.

After discussing the matter in detail member Mr Melwyn Pereira stated that the Gram-sabha meeting notice has been announced in the church on 28/6/2022. That is today morning hence members of Gram-sabha could not attend the meeting as sufficient time was not given to the locals to attend the same further the contents of the memorandums and the components mentioned in the memorandums to declare village under Aspiring category have not been explained in detail to the locals/Gram-sabha members.

Therefore it is proposed by Antonio Alvares seconded ~~and a letter to the~~ ~~and passed unanimously to~~ by Melwyn Pereira and passed unanimously to send a letter to the ~~Director~~ Director of Panchayat to depute a resource person for the Gram-sabha meeting to explain in detail about solid waste management facility required to be followed in the village so as to declare it under ODF plus Aspiring category hence the decision cannot be taken further.

It is also unanimously decided to adjourn the Gram-sabha and the Director of Panchayat that the adjourned Gram-sabha meeting will be held with the availability of resource person at least seven days in advance to give announcement/publicity in the village.
