The presiding officer did not receive any notice of withdrawal of nominations in Form IV from any of the candidates. At 12:10 P.M. the presiding officer published the list of contesting candidates separately showing the names of contesting candidates for each post of Sarpanch and Dy Sarpanch.

Since more than one nominations are received for the post of Sarpanch and Dy Sarpanch it was decided to hold the voting.

The presiding officer prepared the Ballot Paper in form-V for the post of Sarpanch and also a separate ballot paper in form V for the post of Deputy Sarpanch.

Presiding officer showed the Ballot paper to all V.P. members and explained to them that each V.P. member has to come to presiding officer and collect 2 ballot papers (1 of Sarpanch Post and 1 of Deputy Sarpanch Post) and then should go to voting compartment and by using the Ball Point Pen kept in voting compartment has to make cross mark in the space in front of the name of candidate of his/her choice, fold the ballot in the voting compartment itself and then come out and drop the folded ballot paper in the ballot box on presiding officer table. Thereafter ballot paper will be issued to next V.P. member.

The presiding officer explained to all present that if any illegal mark (like signature or initials or some other mark or dot etc) is made by
